SECTION 4: First Aid Measures

4.1 Description of first aid measures

The symptoms resulting from intoxication can appear after exposure, therefore, in case of doubt, seek medical attention for direct exposure to the chemical product or persistent discomfort, showing the SDS of this product.

By inhalation:

If spontaneous vomiting occurs, have victim lean forward with head down to avoid breathing in of vomits, rinse mouth and administer more water. Never give anything by mouth to an unconscious person. Qualified medical personnel should perform administration of oxygen. Seek medical advice if necessary.
