RELEVANT SUBSTANCES:

This product contains Metaldehyde 15g/kg.

- Snails and slugs are mainly active at night, particularly when conditions are warm and
- Scatter ESCARGO 15 RB pellets on the soil in and around beds with young succulent growth where snails occur
- Also scatter ESCARGO 15 RB pellets under and near hiding places such as dense plant growth and plants with large leaves.
- ESCARGO 15 RB pellets are firm, do not disintegrate rapidly and stay effective for a reasonable period.
 - Apply at 10 20 kg per hectare (10 000 m²) for various crops.
